As a member of Saint-Gobain's North American Executive Committee, Carmen Ferrigno reports to the President and CEO of Saint-Gobain Corporation. Ferrigno is responsible for all aspects of external and internal corporate communications, including crisis communications counsel, reputation management and corporate social responsibility. In addition, Ferrigno has overall responsibility for the company's in-house marketing communications agency.



Ferrigno holds a B.A. in political science and English literature, as well as a master's degree in English and writing from Rutgers University. As Executive Director of the Saint-Gobain Corporation Foundation, Ferrigno leads the company's corporate social responsibility strategy and initiatives in North America, including Saint-Gobain's national partnership with YouthBuild USA—a green building education and job training program for former out of school young adults. Ferrigno was

recently named a PR News CSR Professional of the Year for his work transforming Saint-

Gobain's CSR strategy as well as his commitment to corporate stewardship.



Before founding Guildford Group in 2012, Martha McGeary Snider was appointed by Pennsylvania Governor Edward G. Rendell to serve as Policy Advisor on Arts and Culture for both of his terms in office, from 2003 to 2011. She worked directly with the Governor and the Pennsylvania Department of Community and Economic Development to advance cultural, heritage and arts initiatives throughout the Commonwealth. Martha's earlier career included her role as President of Martha Snider Design, LTD, an interior design and consulting firm, and both ownership

and management positions at Spectacor and Comcast-Spectacor, which included her role coordinating all aspects of design for Philadelphia's Wells Fargo Center.

Since 2003, Martha has played a key role as a Trustee on the Board of the Museum of the American Revolution, which opened in April of 2017 in the heart of the historic district in Philadelphia. Other board positions have included the Medici Archive Project in Florence, Italy, the Philadelphia Museum of Art, the Pennsylvania Academy of Fine Arts, the Philadelphia Orchestra, and Philadelphia's Children First Fund.

Martha holds a Fine Arts Degree and a Teaching Certification from Temple University's Tyler School of Art and attended the Art Institute at NYU for her post-graduate studies in Art History. Martha is the mother of two adult children and resides in Wyndmoor, Pennsylvania.

In addition to new board members, the Conservancy continues to grow its staff with the hiring of **Melissa Romero**, **former editor of** *Curbed Philly*, to the communications team, and the hiring of Aliyah Ali and Claire Folkman to roles in administration and finance.
