THE CONSERVANCY DEVELOPS COMMUNITY-DRIVEN CAPITAL PROJECTS THAT HAVE THE POWER TO CHANGE PHILADELPHIA'S CULTURAL LANDSCAPE, RESTORE AND PROTECT THE CITY'S NATURAL AREAS, AND PRESERVE AND REVITALIZE OUR REGION'S HISTORIC AND CULTURAL ASSETS. IN 2019, OUR AWARD WINNING TEAM OF CONSERVATORS COMPLETED 44 LARGE AND SMALL SCALE PRESERVATION PROJECTS THROUGHOUT THE REGION. THE PRESERVATION TEAM ALSO PRESENTED HOMEOWNER WORKSHOPS FOR MORE THAN 80 RESIDENTS AND HOSTED EIGHT INTERNS AND APPRENTICES FROM LOCAL TECHNOLOGY SCHOOLS. THE CONSERVANCY LED THE CREATION OF A COMPREHENSIVE MASTER PLAN FOR THE 348-ACRE FDR PARK IN SOUTH PHILADELPHIA, REACHING OVER 1,300 RESIDENTS AND CONDUCTED IN SEVEN LANGUAGES, WITH THE GOAL OF CREATING A SHARED VISION FOR THE FUTURE OF THE PARK BASED ON THE REALITIES OF CHANGING DEMOGRAPHICS,
